# BSB80320 - Graduate Diploma of Strategic Leadership (Course CRICOS Code - 113603M)

#### What is the BSB80320 - Graduate Diploma of Strategic Leadership and what type of employment opportunities will be available to me when I have attained this qualification?

This qualification reflects the role of individuals who apply advanced knowledge and skills in a range of strategic leadership and management roles.

Individuals at this level make high level autonomous decisions and use initiative and judgement to plan and implement a range of leadership and management functions in varied contexts. They have full responsibility and accountability for personal outputs and for the work or function of others.

They use cognitive and creative skills to review, critically analyse, consolidate and synthesise knowledge, in order to generate ideas and provide solutions to complex problems. They use communication skills to demonstrate their understanding of theoretical concepts and to transfer knowledge and ideas to others.

## What is the duration and mode of study of this course?

52 weeks (including public holidays, re-assessment, and catch-up classes) - full-time study <u>20 contact hours per week</u> timetabled over 2.5 days per week.

### What are the course entry requirements?

- Age 18 and above, Year 12 Education minimum.
- Have completed a Diploma or Advanced Diploma qualification in related fields of study and 3 years' equivalent full-time relevant workplace experience at a significant level of leadership and management responsibility and/or complexity in an enterprise or,
- Have completed a Bachelor degree in related fields of study and 2 years' equivalent full-time relevant workplace experience at a significant level of leadership and management responsibility and/or complexity in an enterprise or,
- Have five years' equivalent full-time relevant workplace experience at a significant level of leadership and management responsibility and/or complexity in an enterprise

# Entry and Admission Requirements for International Students

- Australian International Institute of Technology requires that all International students must be <u>18 years of age or over</u> at the time of enrolment in this qualification and must provide evidence that they have obtained or completed one of the following:
  - Have obtained an IELTS band score of at least 6.0 or equivalent; or 5.5 where the test score is combined with at least 10 weeks ELICOS or 5.5 where the test score is combined with at least 20 weeks ELICOS
  - Have completed the ELICOS Course: General English -Advanced Level
- Note If an International overseas student is unable to provide any of the above evidence at the time of enrolment, they will be required to complete Australian International Institute of Technology's <u>English</u> <u>Language Proficiency Assessment</u> to ensure that they have the required English proficiency level for the course in which they want to enroll.
- Complete a <u>Pre-Training Review</u> and a <u>Language</u>, <u>Literacy and</u> <u>Numeracy (LL&N) Assessment</u> so that Australian International Institute of Technology can determine whether the student needs additional LL&N support during their studies.
- Australian International Institute of Technology will determine any prior learning of each student with regard to their existing skills, knowledge and experience that that the student may have acquired through formal, non-formal and informal learning related to Units of Competency in this qualification in order to determine the amount of training Australian International Institute of Technology will provide to each student (as per Clause 1.2, Standards for Registered Training Organisations 2015).
- If RPL or a Credit is granted, this will result in shorter course duration for this qualification. In addition, Australian International Institute of Technology before providing credit on the basis of a Testamur, Statement of Attainment or Record of Results that have been provided by a student, Australian International Institute of Technology will authenticate the information on these documents (e.g. by contacting the organisation that issued the document and confirming the content is valid).

Participants who have obtained competencies other than via qualification or attainment from other RTO's are given the opportunity, before commencing to obtain exemptions and credits for those units of competency.

**Recognition of Prior Learning - Credit Transfer Exemptions** 

Students who are seeking recognition of prior learning will be provided with the assessment tools for each unit. Students will complete the assessment tasks and/or provide evidence that relates to the assessment tasks.

#### Units of Competency and Topics

<u>08 Units of Competency</u> must be completed with topics including: Social Competence, Leadership, Business Strategy, Business Competence, Project Management, Strategic Formation, Digital Competence, Applied Research Techniques, Relationship Management and Portfolio Management. <u>https://www.aiit.vic.edu.au/courses</u>

#### **Assessment Methods**

The program is classroom-based delivery **face to face** with trainer led training in classrooms, and computer labs consisting of direct observation, product-based methods, portfolios, questioning and third-party evidence.

#### Pathways

Potential employment options could include as a Small Business Manager, Director, Managing Director or Chief Executive Officer.

Students who complete this course may wish to continue their education into higher education qualifications in business and management.
